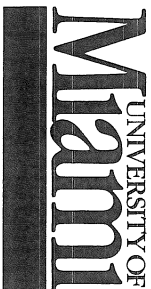

TOM L. BEAUCHAMP, PH.D., is Professor of Philosophy and Senior Research Scholar at Georgetown University's Kennedy Institute of Ethics. He has published numerous articles in medical ethics, professional ethics and philosophy and is the author of the books *The Principles of Biomedical Ethics* (with James F. Childress), *Philosophical Ethics, Medical Ethics* (with Laurence McCullough), and *A History and Theory of Informed Consent* (with Ruth R. Faden).

MARIA JULIA BERTOMEU, PH.D., is Professor and Chair of the Department of Philosophy at the University of La Plata in La Plata, Argentina. She has published a number of articles on ethical theory, applied ethics, Kantian ethics and bioethics committees. She is a member of the Center for Philosophical Investigations in Buenos Aires and is on the Editorial Board of the *Revista Latinoamericana de Filosofia*.

CHARLES CULVER, M.D., PH.D., is Professor of Psychology and Philosophy at Lincoln University College in Buenos Aires. He is working on a number of projects to stimulate the growth of medical ethics in Latin America. He is bioethics columnist for *Consultor*, the Argentine medical newspaper, and author of many articles in psychiatry and bioethics. He is the author of *Philosophy in Medicine* (with Bernard Gert) and editor of *Ethics at the Bedside*.

ANN-LYNN DENKER, R.N. PH.D., is Research Coordinator at University of Miami/Jackson Memorial Medical Center. She is President of the Florida Nurses Association and active in a variety of public and institutional health and policy organizations. She has given numerous presentations and published on aspects of nursing practice, cultural diversity, AIDS and, especially, pediatric AIDS.

HERNAN FUENZALIDA, J.D., is General Counsel and Chief of the Office of Legal Affairs for the Pan American Health Organization (PAHO). He has a number of publications in the field of health and law. He is developing projects in bioethics for PAHO and the parent World Health Organization (WHO), and is responsible for establishing a WHO/PAHO Regional Program in Bioethics with the University of Chile.

BERNARD GERT, PH.D., is Eunice and Julian Cohen Professor for the Study of Ethics and Human Values at Dartmouth College. He has published numerous articles in medical ethics, philosophy and the philosophy of medicine, and is the author of the books *Philosophy in Medicine* (with Charles Culver) and *Morality: A New Justification of the Moral Rules*.

ALBERT R. JONSEN, PH.D., is Professor of Ethics in Medicine and Chairman of the Department of Medical History and Ethics at the University of Washington School of Medicine. He has authored many articles in bioethics, and the texts, *The New Medicine and the Old Ethics* and *The Abuse of Casuistry* (with Stephen Toulmin). He chairs the National Advisory Board on Ethics & Reproduction.

MERVIN H. NEEDELL, M.D., is Medical Director of the University of Miami's Forum for Bioethics and Philosophy. He practiced urology for 30 years and has published a number of articles in urology and urologic surgery. As a "medical missionary" he worked with Dr. Albert Schweitzer in Africa and practiced medicine in Latin America, India, the South Pacific and Africa.

WHO SHOULD ATTEND

This conference will be of value to physicians, nurses, attorneys, philosophers, social workers, risk managers, psychologists and health care administrators and executives.

COURSE OBJECTIVES

Rapid advances in medicine, biology and related fields continue to challenge our ability to apply ethical theory to clinical practice, especially in multicultural environments. This conference brings together three of the world's leading ethicists who will, in an unprecedented exchange, describe and contrast their approaches, in part by conducting comparative case evaluations. This will provide an unparalleled opportunity for those who practice clinical ethics or have an interest in the field. The conference also features a symposium on Bioethics and Transculturalism, a field in which some of the most pressing problems for clinicians and policy makers arise.

The main objectives of this conference are to show how a variety of ethical theories can inform and guide clinical decision making and to identify some key issues that arise in multicultural contexts. Specifically, participants will be able to:

- 1) Distinguish between and among leading theories and approaches to doing clinical ethics. Participants will be better able to evaluate the comparative advantages of each approach.
- 2) Identify leading ethical issues that arise in clinical practice. Development of this skill is one of the most fundamental in clinical ethics.
- 3) Apply their ability to isolate and analyze issues and problems that arise in multicultural health care contexts. It is well known that culture-based values can vary widely, and that this poses special problems in clinical environments.
- 4) Evaluate legal and ethical issues related to immigration and health. Global economic, political and other pressures are creating extraordinary challenges for policy makers, health care providers and ethicists.
- 5) Better understand how ethical theory can be productively applied to real-world clinical dilemmas.
