CLINICAL ETHICS: PRACTICE AND THEORY

PROGRAM OVERVIEW:

The aging of patient populations has focused attention on ethical issues that arise in geriatric care. Many of these ethical issues are especially challenging in the context of health care reform. This conference features a special program on ethics and geriatrics, with the goal that participants will be able to identify such issues and improve their approaches to sound ethical decision making.

Increased demand for bioethics education has accelerated the evolution of institutional ethics committees in hospitals and nursing homes. This conference will address a number of challenges and opportunities for ethics committees, with the goal that participants will be better informed about the proper roles and functions of ethics committees.

A number of factors have led to broadened roles for nurses in primary care. In an extraordinary exchange, the presidents of Florida's nursing and medical associations will offer their views on the proper roles of nurses and physicians in primary care. Participants will be better able to evaluate arguments on both sides of this controversial issue.

This conference will be of value to physicians, nurses, attorneys, philosophers, social workers, risk managers, case managers, clergy, psychologists, researchers, health care administrators and executives, health care ethics committee members, and anyone with an interest in bioethics.


